

Participant Agreement

1. General Program Expectations

All participants are expected to:

- 1.1 Abide by the laws of Canada, the Province of British Columbia, and local municipalities;
- 1.2 Respect Canada's commitment to multiculturalism and human rights by choosing to be non-discriminatory on matters of race, nationality or ethnicity, age, gender, sexual orientation, family status, or religion;
- 1.3 Refrain from obscene, indecent, violent, sexually aggressive, or disorderly conduct;
- 1.4 Refrain from possessing, consuming, or distributing alcohol, cannabis, or any other prohibited substances;
- 1.5 Refrain from driving or purchasing a motorized vehicle (car, motorcycle, or any other vehicle requiring a driver's license);
- 1.6 Refrain from seeking employment on either a full or part-time basis while in Canada;
- 1.7 Maintain regular monthly contact with the participant's assigned FCI Custodian Representative; and
- 1.8 Complete a travel request for any travel outside the metro-Vancouver area.

2. Homestay-Related Program Expectations

Within homestay, all participants are expected to:

- 2.1 Respect the host family's rules and accept assigned responsibilities as an active participant within the home;
- 2.2 Refrain from borrowing money from any member of the host family or other students in the home;
- 2.3 Refrain from using any household appliance without the full knowledge and consent of the host family;
- 2.4 Refrain from storing food or soiled food or drink containers in your bedroom;
- 2.5 Provide advance notice to the host family when the participant does not require dinner or anticipates being late;
- 2.6 Obtain permission from the host family prior to having friends and/or relatives enter or remain in the home; and
- 2.7 Arrive at the participant's assigned homestay prior to established curfew guidelines as presented in FCI's *Orientation Guide for International High School Students Studying in Canada*.

3. School-Related Program Expectations

Within school, all participants are expected to:

- 3.1 Attend all classes regularly. All absences must be reported and satisfactorily explained;
- 3.2 Be punctual, prepared and an active participant in each class;
- 3.3 Complete all classroom and homework assignments;
- 3.4 Adhere to the school's Student Code of Conduct.

4. Consequences of Non-Compliance

First Choice International Placement Inc. reserves the right to dismiss any student who fails to uphold one or more of the above-noted program expectations. In the event a student is dismissed from the program, prepaid program fees will not be refunded.
